A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS CANVASSING RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION, HELD ON MAY 12, 2012.

WHEREAS, on the 9<sup>th</sup> day of February, A.D. 2012, the City Council of the City of Abilene, by proper resolution, ordered a General election to be held in said City on the 12<sup>th</sup> day of May, 2012, in accordance with the provisions of the Charter of said city, for the purpose of electing persons to serve in Council Places 1 & 2; and


PART 3: It appearing that Joe Spano received the majority votes cast in said General Election for the office of Council Place 2; and
