

RESOLUTION NO. 26-2014

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS APPROVING THE CONTRACT BETWEEN THE CITY OF ABILENE AND TAYLOR COUNTY ELECTIONS ADMINISTRATOR FOR A SPECIAL ELECTION TO BE HELD ON JANUARY 13, 2015.

WHEREAS, On October 23, 2014 the Abilene City Council called a Special Election to fill the vacancy of Council Place 6;

WHEREAS, the City and the Elections administrator have determined that it is in the public interest of the inhabitants of the City that the administrator furnish to the City certain election services and equipment needed by the City in connection with the holding of the election on January 13, 2015.

WHEREAS, early voting will take place beginning on January 5th through January 9th 2015 and voting by personal appearance will be conducted at:

Taylor County Elections Office from 8:00 am. until 5:00 pm January 5th, 6th, 7th and 9th and January 8th from 7:00 am. until 7:00 pm.


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:


