

RESOLUTION NO. 41-2015

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS APPROVING PAYMENT TO PEPPER LAWSON WATERWORKS, LLC FOR CONSTRUCTION SERVICES GMP PROPOSAL NO. 3 FOR THE POSSUM KINGDOM RAW WATER ROUGHING FACILITY FOR THE SECOND STAGE SHORT-TERM DROUGHT STRATEGY

WHEREAS, in response to the on-going drought and as part of the City of Abilene's overall second-stage, short-term drought response strategy, the City is implementing Possum Kingdom Lake as a raw water supply that will provide 4 to 14 million gallons of raw water per day to the City of Abilene; and

WHEREAS, On December 18, 2014 the City Council approved a written resolution authorizing the Interim City Manager to negotiate agreements with Pepper Lawson Waterworks, LLC (Pepper Lawson) to serve as the Construction Manager at Risk for the Possum Kingdom Raw Water Roughing Facility which is a required part of the strategy to bring Possum Kingdom water to Abilene; and

WHEREAS, Under the agreement with Pepper Lawson the contract price for the Possum Kingdom Raw Water Roughing Facility is established based on the CMAR's cost of preconstruction phase services, and Guarantee Maximum Price (GMP) proposals accepted by the City; and

WHEREAS, the initial agreement established Preconstruction Phase Services in the amount of \$375,000, equipment purchase of up to \$15,000,000 (GMP No. 1), and the CMAR's fee of 2% for major equipment packages and 4.6% for construction phase services; and

WHEREAS, GMP No. 2 was authorized by the City Council on February 12, 2015 in an amount of \$13,500,000; and

WHEREAS, Pepper Lawson has presented the third GMP (GMP 3) proposal for the following amounts:

CMAR Fee	\$ 378,870
Mechanical Piping Packages (piping between/within structures)	\$1,597,140
Site Civil Packages (excavation and backfill for structures)	\$1,094,950
Structural Concrete Packages (process building and ancillary structures)	\$ 410,000
Buildings and Finishes Packages (precast walls for process building, doors, windows, and HVAC)	\$3,582,620
Electrical Packages (process building and pump stations)	\$1,788,550
Contingency (CMAR-directed contingency in accordance with terms of the CMAR contract)	\$1,000,000
TOTAL GMP NO. 3	\$9,852,130

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

Part 1: The City Manager is hereby authorized to execute any documents necessary to accept Pepper Lawson's GMP proposal No. 3 for the work outlined above.


