

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL ELECTION HELD IN THE CITY OF ABILENE ON MAY 6, 2017 AND ORDERING A RUNOFF ELECTION TO BE HELD ON JUNE 17, 2017.**

*(UNA RESOLUCION DEL CONCEJO DE LA CIUDAD DE ABILENE, TEXAS, SONDEANDO Y DECLARANDO LOS RESULTADOS DE LA ELECCION EN GENERAL LLEVADA A CABO EN LA CIUDAD DE ABILENE EL 6 DE MAYO, 2017 Y ORDENANDO UNA ELECCION POR SEGUNDA VUELTA QUE SE LLEVARA A CABO EL 17 DE JUNIO, 2017.)*

**WHEREAS**, on the 9<sup>th</sup> day of February 2017, the City Council of the City of Abilene, by proper resolution, ordered a General election to be held in said City on the 6<sup>th</sup> day of May, 2017, in accordance with the provisions of the Charter of said city, for the purpose of electing persons to serve as Mayor and Council Places 3 & 4; and

*(CONSIDERANDO, que el día 9 de Febrero de 2017, el Concejo de la Ciudad de Abilene, por resolución apropiada, ordeno una elección en general a llevarse a cabo en dicha ciudad el día 6 de Mayo, 2017, en acuerdo con las estipulaciones de el Fuero de dicha ciudad, para el proposito de elegir a personas para servir como Alcalde y los lugares 3 y 4 del Concejo Municipal; y)*

**WHEREAS**, the City Council has duly canvassed the returns of such election and has ascertained the results; and

*(CONSIDERANDO, que el Concejo Municipal ha debidamente sondeado los resultados de tal elección y ha verificado los resultados; y)*

**WHEREAS**, the City will contract with the Taylor County Election Administrator to conduct the City of Abilene Runoff election; and,

*(CONSIDERANDO, que la Ciudad hará contrato con Taylor County Election Administrator para conducir la elección por segunda vuelta de la Ciudad de Abilene; y)*

**WHEREAS**, per the Charter Section 25 the council shall appoint the election judges and other election officials for City Hall early Vote Center and through the Contract with Taylor County Election Administrator the County Commissioners appoint the election judges and other election officials for the other Vote Centers for early voting and election day; and

*(CONSIDERANDO, segun la Sección 25 de el Fuero, el concejo nombrará a jueces e otros oficiales electorales para el centro de votaciones tempranas en el City Hall y por medio de el Contrato con Taylor County Election Administrator, los comisionados del condado nombrarán a jueces e otros oficiales electorales para los otros centros de votaciones tempranas y día de elección; y)*




PART 6: The City Council appoints the election judges and clerks as shown in “Exhibit B” per the city charter;
