

RESOLUTION NO. 111-2018

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AWARD, THE BULK MATERIALS SUPPLY CONTRACTS TO VARIOUS BIDDERS AS LISTED BELOW - FUNDS ARE AVAILABLE IN THE 2018-19 GENERAL OPERATING BUDGET

WHEREAS, the City of Abilene Street Services Division is requesting the City Council award bids, for materials used in the maintenance of street and alley system. The City of Abilene duly advertised and gave such notice, as required by law, and bids opened on July 10, 2017; and

WHEREAS, the following table lists the individual materials bid, and the staff recommended bidder and unit price bid:

WHEREAS, staff recommends an alternate supply contract with J.H. Strain & Sons Inc. Tye TX, for the purchase of Hot Mix Type D – delivered at the price of \$75.25 per ton when the primary is not able to provide the same material within two days of notice.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the City Council award the supply contracts as listed in the table above, including the alternate contract, recommended by the Street Service's Staff and to authorize the City Manager or his designee to execute all necessary documents related to the contracts.

PART 2: That this Resolution shall take effect immediately from and after passage.


