

RESOLUTION NO. 197-2022

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, AWARDING BID TO EPIC CONSTRUCTION, CO., ABILENE, TEXAS

WHEREAS, the City of Abilene duly advertised and gave such notice, as required by law, for bids for the relocation and reconstruction project along Fulwiler Rd and Marigold St.

WHEREAS, This construction contract involves the relocation of the west 600ft of Marigold St, this relocation will connect Marigold St to Fulwiler Rd. Along with the relocation this contract will include the reconstruction of Fulwiler Rd from Marigold St to Five Points Pwy, as well as the reconstruction of Marigold St from Fulwiler Rd to Polaris Dr. This contract will also include two alternates; alternate 1 is a reconstruction of Marigold St from Polaris Dr to Arnold Bly, and alternate 1 is a construction of a driveway and new parking lot within the Industrial district.

WHEREAS, the City of Abilene has utilized the “Best Value” competitive bidding method in determining the award of the contract; and,

WHEREAS, the following base bids were received and opened on October 12, 2022

Epic Construction Co., Abilene, Texas	\$ 2,278,265.00
Bontke Brothers Construction, Inc., Abilene, Texas	\$ 2,548,852.50

WHEREAS, the following alternate #1 bids were received and opened on October 12, 2022

Epic Construction Co., Abilene, Texas	\$ 843,360.00
Bontke Brothers Construction, Inc., Abilene, Texas	\$ 939,560.00

WHEREAS, the following alternate #2 bids were received and opened on October 12, 2022

Epic Construction Co., Abilene, Texas	\$ 330,030.00
Bontke Brothers Construction, Inc., Abilene, Texas	\$ 368,610.00

WHEREAS, Bontke Brothers Construction, Inc., Abilene, Texas submitted the lowest and best value total for the base bid and both alternates in the amount of \$3,451,655.00 with the bid meeting specifications. Staff recommends awarding the bid to the lowest and best value bidder, Bontke Brothers Construction, Inc., Abilene, Texas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS

PART 1: That the City Council approves this bid in the amount of \$ 3,451,655.00.


PART 2: That this Resolution shall take effect immediately from and after passage.


