AN ORDINANCE EXTENDING THE CITY LIMITS SO AS TO INCLUDE THE PROPERTY HEREIN DESCRIBED:

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

SECTION I: WHEREAS, the owners of the following described property lying adjacent to, and adjoining the corporate limits of the City of Abilene have made application to the Board of Commissioners of the City of Abilene, requesting that said property be annexed to, and included within the corporate limits of the City of Abilene, said property being described by metes and bounds as follows:

All that certain tract or parcel of land situated in Taylor County, Texas, to-wit:

Beginning at the most Northerly N. W. Corner of the N. W. fractional one-fourth (1/4) of Section No. Fifty, (50), Blind Asylum Lands, Taylor County, Texas; thence N. 89 deg. 34° E. along the North line thereof a distance of one thousand three hundred, twenty three (1323) feet to the N. E. Corner of said quarter section; thence S. O deg. 30° E. along the east line of said quarter section a distance of one thousand seventy three and six-tenths (1073.6) feet; thence S. 89 deg. 40 W. a distance of one thousand three hundred twenty four and seven-tenths (1324.7) feet to the west line of said quarter section; thence N. O deg. 20° W. along said West line a distance of one thousand seventy one and three-tanths (1071.3) feet to the place of beginning, containing 32.6 acres of land, more or less.

SECTION II: That said above described property according to metes and bounds as herein set out, be and the same is hereby declared annexed to the City of Abilene, and an integral part of said city, and incorporated within the limits of said city.

SECTION III: That the city limits of the City of Abilene be extended as follows, so as to include the above described property, to-wit:

Beginning at the Southeast corner of Lot No. Two (2), Block A, Ledbetter Addition to the City of Abilene, a point in the present city limits; thence southward with the West Boundary line of Oak Street extended at a distance of one thousand seventy-three and six tenths (1073.6) feet, to the south boundary line of South Eighteenth streetof the Belmont addition to the City of Abilene, Texas; thence westward along the South Boundary line of South Eighteenth street, and the south line of Lot Number Two (2), Belmont addition to the City of Abilene, Texas, a distance of one thousand three hundred twenty four and seven tenths (1324.7) feet to the West boundary line of the Northwest one-fourth of fractional section number Fifty (50), Blind Asylum Lands; thence Northward with the West Boundary line of the Northwest onefourth of fractional section Number Fifty, Blind Asylum Lands, a distance of eight hundred and forty-three and three tenths (843.3) feet to the Southeast corner of Lot Number One (1) Block C, of Andersons' addition to the City of Abilene, a point in the present city limits.

SECTION IV: That this ordinance shall take effect and be in force from and after its passage.
