AN ORDINANCE ANNEXING ABILENE HEIGHTS AND THE PROPERTY HEREIN DESCRIBED BY METES AND BOUNDS, SITUATED IN TAYLOR COUNTY, TEXAS TO THE CITY OF ABILENE, TAYLOR COUNTY, TEXAS.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

SECTION NO. ONE: Whereas, the owners of the hereinafter described property lying adjacent and contiguous to and adjoining the corporate limits of The City of Abilene, Texas, have made application to the Board of Commissioners of said City of Abilene, requesting that said property be annexed to and included within the City Limits of said City of Abilene, Texas, said property being situated in Taylor County, Texas and described by metes and bounds as follows, to-wit:

Beginning at an iron pipe set for the center of Sur. # 34, Blind Asylum Lands, Taylor Co., Texas, being the common corner of all four quarters of said survey:

Thence N. 900 ft. with the W.B.L. of the N.E. $\frac{1}{4}$ of this survey No. 34, to its intersection with the N.B.L. of Nineteenth Street, Abilene, Texas for corner:

Thence E. 2675 ft. with the N.B.L. of Nineteenth Street to its intersection with the E.B.L. of Ave. "F", for the N.E. Cor. of this tract:

Thence South 2540 ft. with the E.B.L. of Ave. "F" to its intersection with the S.B.L. of Thirteenth Street for the S.E. Cor. of this tract:

Thence W. 1370 ft. with the S.B.L. of Thirteenth Street to a point where the W.B.L. of Ave. "E" extended south intersects with said S.B.L. of Thirteenth Street for the most southerly S.W. Cor. of this tract:

Thence N. 360 ft. with the W. B.L. of Ave. "E" to its intersection with the S.B.L. of Fourteenth Street for corner:

Thence W. 660 ft. with the S.B.L. of Fourteenth Street to its intersection with the W.B.L. of Ave. "D" for corner:

Thence N. 360 ft. with the W.B.L. of Ave. "D" to its intersection with the South B.L. of Fifteenth Street for corner:

Thence W. 630 ft. with the S.B.L. of Fifteenth Street to its intersection with the W.B.L. of the S.E. $\frac{1}{4}$ of this survey and the W.B.L. of Ave. "C" for corner:

Thence N. 270 ft. with the W.B.L. of said S.E. $\frac{1}{4}$ of this survey, same being the W.B.L. of Ave. "C", to its intersection with the S.B.L. of ~~College~~ College Drive for Corner:

Thence with the S.B.L. of said College Drive a distance of 1854 ft. to its intersection with the E.B.L. of the Abilene and Northern Railway Company right of way, same being the E.B.L. of the City Limits of The City of Abilene, Texas:

Thence 10 degrees 22' west with the Abilene and Northern Railway Company's right of way and on the E.B.L. of City Limits, a distance of 443 ft. for corner:

Thence in an easterly direction and slightly northeasterly with the N.B.L. of an unnamed street 440 ft. from and parallel to the S.B.L. of College Drive to the intersection of the N.B.L. of said unnamed street with the center line of Cedar Creek in the W.B.L. of Lot No. 5, Block No. 19, Abilene, Heights Addition:

Thence in a northerly direction down the center line of Cedar Creek to its intersection with the N.B.L. of the S.W. $\frac{1}{4}$ of Sur. 34, Blind Asylum Land for corner:

Thence E. 635 ft. with the N.B.L. of the S.W. $\frac{1}{4}$ of Sur. No. 34, Blind Asylum Lands aforesaid to the place of beginning and contain- 167 and 6/10 acres of land more or less.
