

AN ORDINANCE FIXING WATER AND SEWER
RATES INSIDE AND OUTSIDE THE CITY
LIMITS, REPEALING ALL EXISTING
ORDINANCES IN CONFLICT HEREWITH AND
DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

SECTION I. That the rates to be charged by the City of Abilene for water and sewer services be and the same is hereby fixed as follows:

(a) WATER RATES

1. Inside City Limits

Minimum charge per month inside city limits for 5000 gallons-
\$1.50:

Excess over 5000 gallons per month inside city limits-
20¢ per 1000 gallons.

2. Outside City Limits

Minimum charger per month outside city limits for 5000 gallons-
\$3.00;

Excess over 5000 gallons per month outside city limits-50¢
per 1000 gallons.

(b) SEWER RATES

1. Inside City Limits

For first fixture- 75¢ per month;

For next 24 fixtures - 25¢ each per month;

For all fixtures over 25- 12½¢ each per month.

2. Outside City Limits

For First fixture - \$1.50;

For next 24 fixtures - 50¢ each per month;

For all fixtures over 25 - 25¢ each per month.

SECTION II.

All accounts which are due and payable from September 15 to September 25, 1949, will be billed and payable at the rates herein fixed. All accounts which are due and payable from October 10 to October 25, 1949, will be billed at the rates herein fixed.

SECTION III. It is hereby specifically stipulated that any and all ordinances and resolutions now in effect granting discounts for prompt payment of accounts are hereby repealed.

SECTION IV. All ordinances or resolutions or parts thereof in conflict herewith are hereby repealed.

SECTION V. The fact that the present ordinance fixing water and sewer rates has by its own terms expired creates a public emergency requiring that this ordinance be passed on the date of its introduction and that the charter provisions requiring that ordinances be read at two separate meetings of the Board of Commissioners be and the same is hereby suspended and this ordinance is hereby read and passed twice at one and the same meeting of said board and shall become effective immediately upon passage.
