

ORDINANCE NO. 478

AN ORDINANCE CHANGING THE NAME  
OF A PORTION OF JACKSON STREET TO  
SOUTH 19th STREET.

WHEREAS, Jackson Street now runs from South 17th Street South approximately 1240 feet and then turns East and runs approximately 750 feet more or less paralleling South 20th Street; and

WHEREAS, said East and West portion of said Jackson Street is confusing to the general public and property owners facing said East and West portion of said Street; and

WHEREAS, said property owners are confused by having duplicated house numbers on said East and West portion of said Street..

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

Section 1. That the portion of Jackson Street which lies West of Palm Street and East of Jeanette Street be and the same is hereby changed and redesignated as South 19th Street.

SECTION 2. That the City Engineer is hereby directed to cause said Streets to be properly marked as herein provided and to change the official maps of the City of Abilene in accordance herewith.

Passed on first reading this the 25th day of April, A.D. 1952.

After said passage a notice of the time and place when and where said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, said publication being on the 29th day of April, at least one week prior to the time advertised. After such opportunity for the public to be heard said ordinance was passed on its second and final reading on the 9th day of May, A.D. 1952.
