AN ORDINANCE PROVIDING FOR THE EXTENSION OF THE LIMITS OF THE CITY OF ABILENE AND THE ANNEXATION OF CERTAIN ADDITIONAL TERRITORY LYING ADJACENT TO THE SURROUNDING THE BOUNDARIES OF THE CITY OF ABILENE, SAID ADDITIONAL TERRITORY BEING AS HEREINAFTER DESCRIBED.

WHEREAS, Section 4 of the Charter of the City of Abilene, Texas, provides that the City shall have power, by ordinance, to fix and change the boundaries and limits of the city and to provide for the extension of said boundaries and limits and the annexation of additional territory lying adjacent to the city with or without the consent of the territory and inhabitants thereof annexed; and

WHEREAS, it appears expedient and necessary to the Board of Commissioners of the City of Abilene, that certain property hereinafter described be annexed for all purposes in accordance with the City Charter; NOW THEREFORE:

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF ABILENE, TEXAS:

Section 1: That the boundary and limits of the City of Abilene are hereby changed and fixed and the extension thereof provided for, and the present boundaries and limits of said city are hereby changed so as to include all of that territory lying and being situated adjacent to the city limits of the City of Abilene and described as follows, to wit:

BEGINNING at a point in the present City Limits where the W R.O.W. line of Hollywood Dr. extended intersects the N R.O.W. line of S 11th St;

THENCE S to a point in the W. R.O.W. line of said Hollywood Dr. and the N.E. corner of Lot 37 of the Etheridge Addn. of 13.9 acres in the E end of Lots 2 & 3, Blk 210, Original Town;

THENCE W with the N line of Lot 37 150' to the N. W. corner of said Lot 37;

THENCE S with the W line of said Etheridge Addn to the S.W. corner of Lot 52 in said Etheridge Addn;



THENCE E to a point the intersection of the S. R.O.W. line of Doris St and the E. R.O.W. line of Viola St;

THENCE N with the E line of said Viola St to a point the intersection of the E. R.O.W. line of said Viola St and the N. R.O.W. line of Conally St;

THENCE W to a point the N. R.O.W. line of said Conally St and the E. R.O.W. line of Hollywood Dr;

THENCE N with the E. R.O.W. line of said Hollywood Dr to a point of intersection of said E. R.O.W. line of Hollywood Dr extended to the N. R.O.W. line of S 11th St;

THENCE in a westerly direction with the N. R.O.W. line of S 11th St and the said City limits a distance of 25' more or less to the place of beginning.

Section 2: That upon final passage hereof, said property annexed shall be a part of the City of Abilene, Texas, and the property situated therein shall bear its pro rata portion of the taxes levied by the city, and the inhabitants thereof shall be entitled to all of the rights and privileges of all of the citizens and shall be bound by the acts, ordinances, rules and regulations of the city.

Section 3: That the City Engineer shall change the records of his office to conform to the new boundaries and limits of the City of Abilene as changed and fixed by this ordinance.

Section 4: The aforesaid boundary and limits shall include the territory over which the City of Abilene has jurisdiction.

PASSED ON FIRST READING this the 2<sup>nd</sup> day of May, 1957.

The City Secretary is hereby directed to publish this ordinance at least one time in the Abilene Reporter News and it shall not be finally passed until at least thirty (30) days have elapsed after said publication thereof.

PASSED ON SECOND AND FINAL READING, this 13<sup>th</sup> day of June, 1957.
