AN ORDINANCE NAMING STREETS AS SET OUT BELOW.
AND CALLING A PUBLIC HEARING ON September 1, 1960.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF
THE CITY OF ABILENE, TEXAS:

West Phantom Hill Road	N&S	From East Ambler Ave. North along the West side of Lake Fort Phantom Hill to Johnson Road.
Manly Road	N&S	N.E. corner of Lake Fort Phantom Hill from East Phantom Hill Road and continues South to East Ambler Avenue.

PASSED ON FIRST READING ON This the 11th day of August, A.D., 1960.

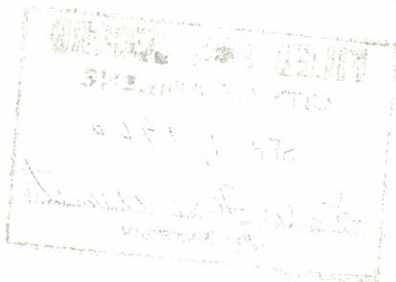
