

ORDINANCE NO. 390

AN ORDINANCE OF THE CITY OF ABILENE, TEXAS, PROVIDING FOR THE EXTENSION OF THE BOUNDARY LIMITS OF THE CITY OF ABILENE AND THE ANNEXATION OF CERTAIN ADDITIONAL TERRITORY LYING ADJACENT TO AND ADJOINING THE PRESENT BOUNDARY LIMIT OF THE CITY OF ABILENE, TEXAS; AND CALLING A PUBLIC HEARING

WHEREAS, a public hearing before the City Council of the City of Abilene, Texas, where all interested persons were provided with an opportunity to be heard on the proposed annexation of the territory hereinafter described, was held at 2:00 P.M. on the 3rd day of June, A.D., 1968, which date was not more than twenty nor less than ten days prior to the institution of these annexation proceedings; and

WHEREAS, notice of such public hearing was published in a newspaper having general circulation in the City of Abilene, Texas, and in the herein described territory on the 23rd day of May, A.D., 1968, which date was not more than twenty nor less than ten days prior to the date of such public hearing; and

WHEREAS, the herein described territory lies within the extraterritorial jurisdiction of the City of Abilene, Texas; and

WHEREAS, the hereinafter described territory is not in excess of the amount of territory which the City of Abilene is authorized to annex by the provisions of the Municipal Annexation Act, Article 970a, Vernon's Annotated Civil Statutes, and

WHEREAS, the hereinafter described territory should be annexed to and made a part of the City of Abilene; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE,

TEXAS:

Section 1: That the following described land and territory lying adjacent to and adjoining the City of Abilene, Texas, is hereby added and annexed to the City of Abilene, Texas, and said territory hereinafter described shall hereafter be included within the boundary limits of the City of Abilene, Texas, and the present boundary limits of such city, at the various points contiguous to the

area hereinafter described, are altered and amended so as to include said area

within the corporate limits of the City of Abilene, Texas, to-wit:

Section 2: That the above described territory and the area so annexed shall be a part of the City of Abilene and the property so added hereby shall bear its pro rata part of the taxes levied by the City of Abilene, and the inhabitants thereof shall be entitled to all of the rights and privileges of all the citizens and shall be bound by the acts, ordinances, resolutions and regulations of the City of Abilene.

Section 3: That this ordinance shall be published and passed in the manner provided in Section 4 of the Charter of the City of Abilene, Texas, and the City Secretary shall give notice that a public hearing shall be held thereon at 8:30 A.M. on July 25, 1968, in the Council Room of the City Hall, City of Abilene, Taylor County, Texas, after which such public hearing this ordinance may be passed on second and final reading.
