

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS, CHANGING THE NAME OF THE PORTION OF LA SALLE DRIVE SOUTH OF SOUTH 14TH STREET, TO FRENCHMAN'S CREEK ROAD.

WHEREAS, a portion of LaSalle Drive in the City of Abilene, extends south of South 14th Street; and,

WHEREAS, it is the recommendation of the City's Planning and Zoning Commission that the portion of LaSalle Drive extending south of South 14th Street should be named Frenchman's Creek Road; and,

WHEREAS, it is the opinion of the City Council that the portion of LaSalle Drive extending south of South 14th Street should be named Frenchman's Creek Road; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the portion of LaSalle Drive extending south of South 14th Street be changed and will hereafter be known as Frenchman's Creek Road.

PART 2: That the City Engineer be, and is hereby authorized and directed to change his maps, plats and records to indicate such name to be the proper name of that portion of the street in question.

PART 3: That the City Planning Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the City Planning Department shall provide notice of the naming of such street to all other City departments, including the Fire and Police Departments.

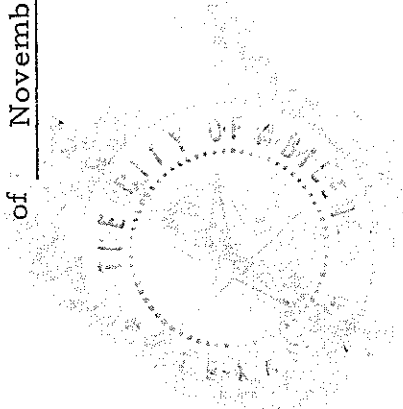
