ORDINANCE NO. 1021

AN ORDINANCE AMENDING ORDINANCE NO. 704, ABANDONMENT OF A PORTION OF CEDAR STREET, TO PROVIDE THE RIGHT TO ERECT PERMANENT STRUCTURES OVER SAID EASEMENT AND CALLING A PUBLIC HEARING.

WHEREAS, the City Council of the City of Abilene abandoned an easement on June 13, 1974; and,

WHEREAS, said abandonment Ordinance provided "that no permanent structures will be placed on said easement"; and,

WHEREAS, a request has been made that said restriction be removed from said Ordinance; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That said Ordinance No. 704, passed on second reading June 13, 1974, be amended by deleting the following phrase:

"with the further restriction that no permanent structures will be placed on said easement."

PART 2: That, upon final passage hereof, the City Secretary be, and she is hereby authorized and directed to certify a copy of this Ordinance, and file it in the Deed Records of Taylor County, Texas.

PASSED ON FIRST READING, this the 12th day of January, A.D. 1978.

After said passage, a Notice of the time and place, where and when said Ordinance would be given a public hearing and considered for final passage, was published in the Abilene Reporter News, a daily newspaper, of general circulation in the City of Abilene, said publication being on the 20 day of January, A.D. 1978, the same being more than twenty-four (24) hours prior to the time designated for said hearing. After such opportunity for the public to be heard, said Ordinance was passed on second and final reading.
