AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS,
CHANGING THE NAME OF PIPING ROCK DRIVE TO MEADOWLAKE DRIVE.

WHEREAS, it is the recommendation of the Planning and Zoning Commission of the City of Abilene that the most southerly east and west segment of Piping Rock Drive, in the City of Abilene, which is located in Woodlake Addition, Section 3, should be renamed Meadowlake Drive; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That the most southerly east and west segment of Piping Rock Drive which is located in Woodlake Addition, Section 3, be renamed and will hereafter be known as Meadowlake Drive.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Community Development Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the Planning, and Community Development Department shall provide notice of the renaming of such street to all other City departments including the Fire and Police Departments.

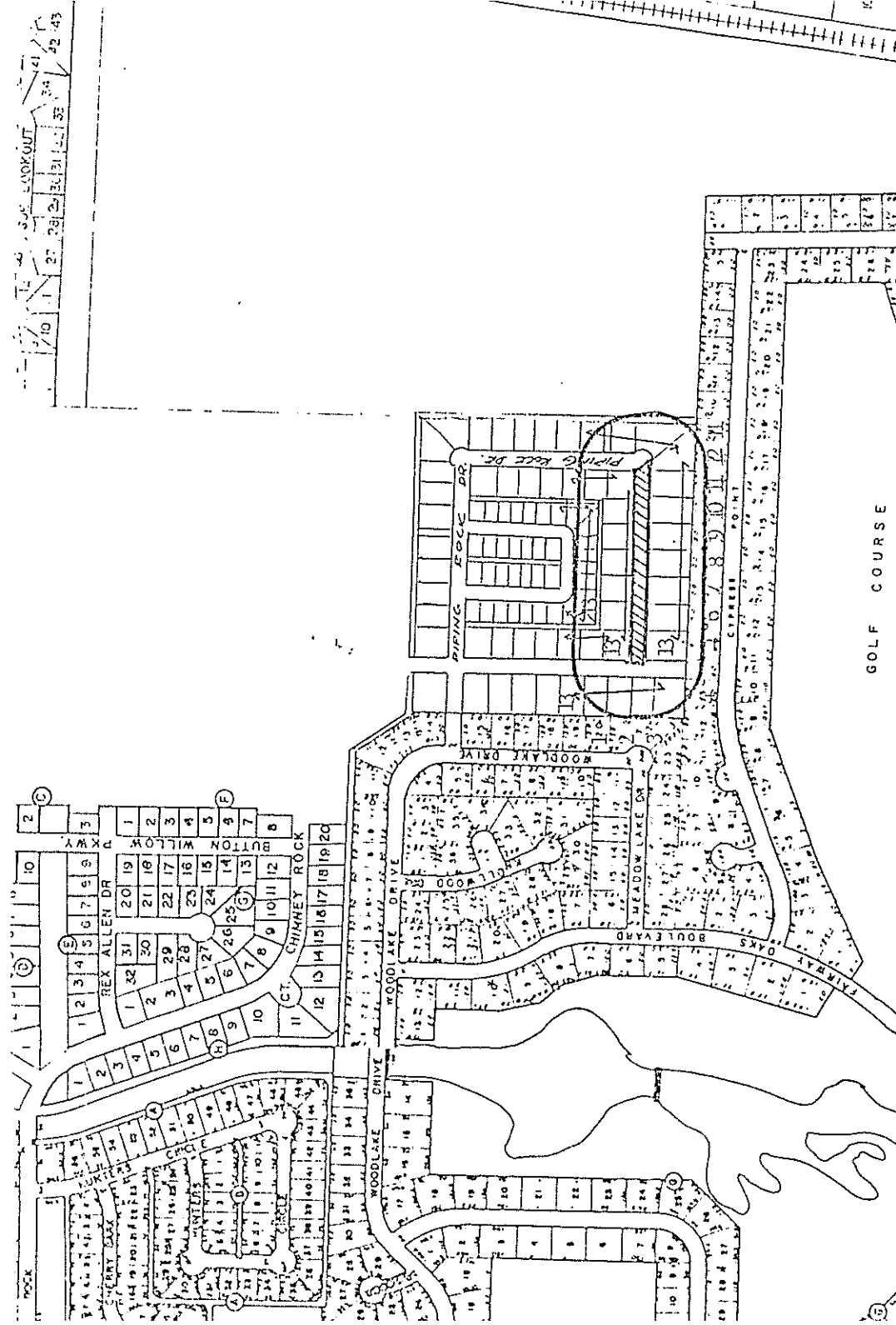

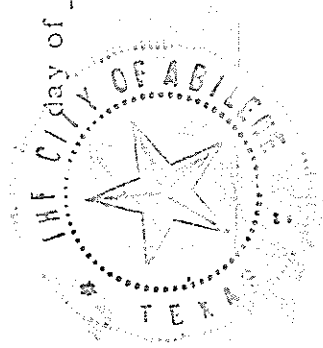
