WHEREAS, it is the opinion of the City Council that Ruby Ester Circle should be renamed Ruby Esther Circle; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Ruby Ester Circle, which is in Mesquite Forest Estates, Section 3, be renamed and will hereafter be known as Ruby Esther Circle.

PART 2: That the City Engineer be and is hereby authorized and directed to change his maps, plats and records to include such name to be the proper name of the street described above.

PART 3: That the Planning and Community Development Department be, and is hereby authorized and directed to change its maps, plats and records to reflect such name change, and further that the Planning and Community Development Department shall provide notice of the renaming of such street to all other City departments including the Fire and Police Departments.

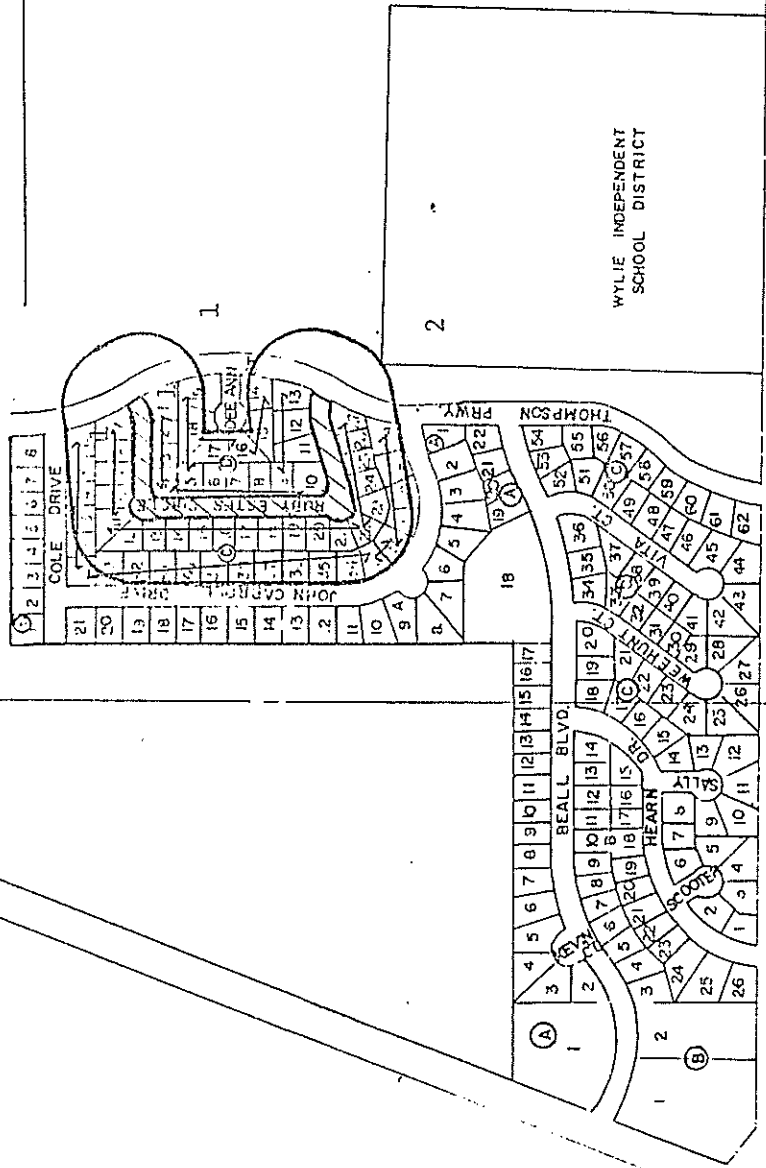
