

ORDINANCE NO. 60-1986

AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC", OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Chapter 18, "Motor Vehicles and Traffic", of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

PART 2: That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force and effect.

PART 3: That any person, firm, or corporation violating any of the provisions of this chapter shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not more than Two Hundred Dollars (\$200.00). Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.

Section 18-285. Increased Speed Limits.

DELETE:

<u>Street</u>	<u>Extent</u>	<u>Speed</u>
Arnold Blvd.	From Dyess Air Force Base Main Gate to US 80 West	40

ADD:

<u>Street</u>	<u>Extent</u>	<u>Speed</u>
Arnold Blvd.	From US 80 West (S. 1st St.) to Military Dr.	40
Arnold Blvd.	From Military Dr. to Hartford St.	45
Dub Wright Blvd.	From Hartford St. to US 277	50

Section 18-286. Decreased Speed Limits - School Zones.

ADD to Subsection (b):

<u>School</u>	<u>Street</u>	<u>Extent</u>
Mann Middle School	Ambler Ave.	300 feet east of Mimosa Dr. to 300 feet west of Mimosa Dr.

ADD Subsection (c) as follows:

(c) In accordance with the provisions of this chapter, and when traffic-control devices or signs are erected giving notice thereof, the prima facie speed limit shall be thirty (30) miles per hour for hours designated on school days, where school signs are posted or at any time when electrical control devices are in operation, on the following streets or portions of streets:

DELETE:

ADD:

EN 16th St.	North	From Pemelton Dr. west a distance of 350 feet.
EN 16th St.	South	From Newcastle Dr. east a distance of 150 feet.
Barrow St.	East	From S. 27th St. south a distance of 150 feet.
State St.	North	From 150 feet east of Forrest Ave. to 100 feet west of Forrest Ave.
State St.	South	From 100 feet east of Forrest Ave. to 150 feet west of Forrest Ave.
Texas Ave.	South	From US 277 to Dub Wright Blvd.

	North	From 500 feet east of Corsicana Ave. to Dub Wright Blvd.
