AMEND: PART 4, paragraph B(2) to read:

(2) Proposed Lots 221-235, Block B, a replat of Lots 121-145, Block B, of a replat of Lots 21-35, Block B, The Fairways; file number MRP-1891 located in the Planning Department; shall be used only for single family residential construction. The minimum building standards for the above said lots shall be as follows:

front - 10'
side - 5'/7'
rear - 20' from garage, otherwise 10'
