

ORDINANCE NO. 19-2009

AN ORDINANCE APPROVING A REVISION TO SECTION 7 OF ORDINANCE NUMBER 50-2008; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; CALLING A PUBLIC HEARING.

WHEREAS, the City Council has adopted Ordinance Number 50-2008; and,

WHEREAS, said Ordinance established the number, classification, and designation of each position, as provided in Texas Local Government Code Ann., Chapter 143 (Vernon 1988), Municipal Civil Service, for the Police and Fire Departments; and,

WHEREAS, Section 7 of said Ordinance allows amendment by the City Council during the fiscal year the Ordinance is in effect; and,

WHEREAS, the Chief of the Abilene Fire Department has requested a reduction in the number of approved positions within the rank of Fire Captain and an increase in the number of approved positions within the rank of Firefighter to account for a reduction through attrition at the rank of Fire Captain,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:

PART 1: That Ordinance Number 50-2008 is amended as set forth in Attachment A.

PART 2: That any ordinance, resolution, policy or any provision or section of the code of the City of Abilene, Texas, as amended, in conflict herewith, be, and the same is hereby repealed to the extent of any conflict.

PASSED ON FIRST READING on the 15 day of June, A.D. 2009.



ATTACHMENT A

That Part 7 of Ordinance No. 50-2008 is hereby amended to read as follows:

Part 7: That the number, classification, and designation of each position, as provided in Texas Local Government Code Ann., Chapter 143 (Vernon 1988), Municipal Civil Service, for the Police and Fire Departments, as set out below, are hereby created, established, and adopted as the official plan for the classified service of the Police and Fire Departments of the City of Abilene for the remainder of the fiscal year October 1, 2008, through September 30, 2009, or as may be amended by the City Council. Any position in the classified service of the Police and Fire Departments of the City of Abilene not below listed, is hereby abolished:
