

**ORDINANCE NO. 01-2019**

**AN ORDINANCE AMENDING CHAPTER 18, "MOTOR VEHICLES AND TRAFFIC," ARTICLE XIII, SECTION 18-287, "SAME OTHER ZONES," SECTION 18-289, "ONE-WAY STREETS-AT ALL TIMES," SECTION 18-293, "PARKING PROHIBITED—AT ALL TIMES," SECTION 18-299, "PARKING TIME LIMITED," OF THE ABILENE MUNICIPAL CODE, BY AMENDING CERTAIN SECTIONS AS SET OUT BELOW; PROVIDING A SEVERABILITY CLAUSE; AND DECLARING A PENALTY**

**WHEREAS**, in 2008 major improvements were made to the Abilene Municipal Airport parking lot and surrounding streets adjacent to the terminal; and

**WHEREAS**, there is a need to make the code of ordinances reflect the changes in these streets that have already been implemented by signage and traffic control measures.

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS:**

**PART 1:** That Chapter 18, Article XIII, Section 18-287 of the Abilene Municipal Code be repealed and reserved as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

**PART 2:** That Chapter 18, Article XIII, Section 18-289 of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

**PART 3:** That Chapter 18, Article XIII, Section 18-293 of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

**PART 4:** That Chapter 18, Article XIII, Section 18-299 of the Abilene Municipal Code be amended as set out in Exhibit "A", attached hereto and made a part of this ordinance for all purposes.

**PART 5:** That if any provisions of any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way effect the validity of the remaining provisions or sections of this ordinance, which shall remain in full force or effect.

**PART 6:** That any persons, firm, or corporation violating any of the provisions of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punishable by a fine in accordance with Chapter 1 (Section 1-9) of this Code. Each day such violation shall continue or be permitted to continue, shall be deemed a separate offense. Said Ordinance, being a penal ordinance, becomes effective ten (10) days after its publication in the newspaper, as provided by Section 19 of the Charter of the City of Abilene.

**PASSED ON FIRST READING this 20<sup>th</sup> day of December, 2018.**

A notice of the time and place, where and when said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, said publication being on 6<sup>th</sup> day of January, 2019, the same being more than 24 hours prior to a public hearing being held in the Council Chamber of City Hall in Abilene, Texas, at 8:30 a.m. on the 10<sup>th</sup> day of January, 2019, to permit the public to be heard.

In accordance with the provisions of this chapter, and when signs are erected giving notice thereof, no person shall at any time park a vehicle upon the indicated side of any of the following streets or portions of streets:

**Sec. 18-299. Parking time limited.**

In accordance with the terms of this chapter, and when signs are erected giving notice thereof, no person shall stand, stop or park a vehicle in excess of the indicated period of time specified in this schedule on the indicated days on the indicated sides of the following streets or portions of streets. Each consecutive increment of the time limit during which a vehicle remains continuously parked shall be deemed to be a separate offense.
