

ORDINANCE NO. 19-2019

AN ORDINANCE AMENDING ORDINANCE 54-2018 ADOPTING FEES AND CHARGES, BY AMENDING AND ADDING FEES FOR PERMIT FOR SCOOTER AND BICYLCES SHARING VENDORS; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES, RESOLUTIONS AND PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING A SEVERABILITY CLAUSE; AND CALLING A PUBLIC HEARING.

WHEREAS, the City Council adopted Ordinance 54-2018 (the “Fee Ordinance”) on September 13, 2018 setting fees and charges commencing on October 1, 2018; and

WHEREAS, it was contemplated that the Fee Ordinance would require amendment from time to time to modify and update fees and charges; and

WHEREAS, the City Council adopted Ordinance 13-2019 (the “Scooter and Bicycle Sharing” Ordinance) on February 28, 2019; and

WHEREAS, the Scooter and Bicycle Sharing Ordinance contemplated that the fee for a permit would be included in the City’s Fee Ordinance.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS;

Part 1: That the Schedule of Fees and Charges for issuance of a permit for Scooter and Bicycles Sharing Vendors be added as set forth in Exhibit “A”, attached hereto and made a part of this Ordinance 54-2018 for all purposes.

Part 2: That all ordinances, parts of ordinances, resolutions and parts of resolutions in conflict herewith are repealed.

Part 3: That if any provision or any section of this ordinance shall be held to be void or unconstitutional, such holding shall in no way affect the validity of the remaining provisions or sections of this ordinance 54-2018, which shall remain in full force and effect.

PASSED ON FIRST READING on the 14th day of March, 2019.

A notice of time and place, where and when said ordinance would be given a public hearing and considered for final passage was published in the Abilene Reporter-News, a daily newspaper of general circulation in the City of Abilene, said publication being on the 24th day of March, 2019, the same being more than 24 hours prior to a public hearing being held in the Council Chamber of City Hall in Abilene, Texas, at 7:15 a.m. on the 28th day of March, 2019, to permit the public to be heard.

PASSED ON THE SECOND AND FINAL READING this 28th day of March, 2019.


